GVTS 2021-22 OPERATIONAL DEFICIT

• The difference between the projected expenses and projected revenue is approximately \$500,000, if left unchanged. Board approved budget was \$1.2 million, balanced with 139 students and lower facility costs.

REVISED BUDGET

Proposed changes

- administrative costs shifted to River and Orchard
- No office manager
- Cap on all discretionary expenses (Professional development, conferences, supplies)
- Use all cash reserves
- Delay last payment of \$25,000 payment to River
- Move out of Sierra by January




